B. Technical Specification:

C. Quoting Format (Priced):

The rates must be quoted separately for 1st year and successive years, signed and stamped. It should be inclusive of all duties, taxes and other levies payable by the bidder Each bidder must submit only one quotation.

D. Time of Completion:

7 days from the issue of work order.

E. Payment:

Full Payment shall be made on submission of bills in triplicate after delivery and successful installation and deployment of the entire system. No interim payment will be given. Vendor has to submit 40% of the final bill as security deposit in the form of Bank Draft/Check/Bank Guarantee out of which 75% (30% of total bill) will be released after successful service of 1 year and the rest 25% (10% of total bill) will be released at the successful service of 2 year. If the vendor fails to provide the required services in the due course of project (2 years for present bid), the vendor will be liable to pay 100% penalty to the college.

F: Eligibility Criterion:

- a) Email or Facsimile quotations are not acceptable.
- b) The Vendor must be registered under Companies Act (Proof Required)
- c) The Vendor must provide valid photo copies of VAT Registration Certificate & Trade License, Service Tax, Professional Tax and ITR Assessment for last three financial years
- d) The Vendor should have an office for support in Kolkata.
- e) The Vendor should be competent with the local language of West Bengal (Bengali).
- f) The Vendor should have credentials of similar work in at least 10 Higher Educational Institute (Colleges/Universities/Research Institute) and minimum three years experience in Open Source Software Implementation.
- g) The source code for all the solution components to be used/integrated for the proposed deployment must be freely available under an open source license

G: Other Terms & Conditions on services required:

- a) Latest stable version of open source Software package Moodle (Learning Management System) should be implemented. Any new release for updates and upgrades should be implemented during contract period.
- b) Data Backup: Regular data backups should be made available.
- c) Data Privacy, Confidentiality & Security: Vendor should strictly ensure privacy, confidentiality and security of all users' data.
- d) Freedom from vendor lock-in: Customer will own both installed/customised web/software package and data and should be able to switch the vendors at any time. In case, for any reason, if vendor discontinues the arrangement of hosting and maintenance of clients data for some reason or client wants to run their own server, a notice of minimum one month's should be given from either side and vendor should facilitate smooth transfer of data to customer's server, so that the services are not disrupted at any point of time.
- e) Administrative power should be given to the College Authority (IQAC).
- f) The term of the contract will start from the date of operation (i.e. after hand-over of the system to the institute for live operation) till the two years.
- g) The vendor should provide its representatives in the due course of inspection, NAAC visit or for some special occasions.
